Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of Director of Education, Govt. of NCT of Delhi for grant of provisional Recognition from class 1<sup>st</sup> to Sr. Secondary Level (with Arts & Commerce) in r/o Guru Nanak Garib Niwaj Education School, Nanaksar Complex, Opposite M - 41, Greater Kailash - II, New Delhi - 110048 w.e.f academic session 2021-22 upto 31/03/2023 under DSEAR, 1973, subject to the following terms and conditions:-

1. That the school shall abide by the provisions of DSEAR, 1973 and RTE Act, 2009 made there under as well as the instructions issued by the Director of Education from time to time.
2. That all the facilities prescribed under section 4 of DSEAR, 1973 read with rule 50 & 51 of DSEAR, 1973, shall be made available to the students.
3. That the school shall admit the students without any discrimination of religion race, caste or place of birth as per the norms of the Department.
4. That the school shall follow the three language formula for teaching.
5. That the school shall not run any unauthorized classes or any other activities within the school premises and all the recognized classes shall run at one place in the premises of school.
6. That the managing committee shall regulate the functioning of school strictly in accordance with the provisions of DSEAR, 1973/RTE Act, 2009.
7. That the Management of the school shall create a reserve fund in the form of Fixed Deposit in the joint account in the name of Manager of the School and Dy. Director of Education (Distt. ) equivalent to 3 months salary of staff or Rupees One lakh + Rs 80/- per student within 3 months from the date of issue of letter.
8. That in no case the school funds will be diverted/ transferred to any other fund/account of the society. The school funds will also not be utilized by the society for any other purpose other than that of the school.
9. That the school shall ensure that the Fire safety equipments and arrangements are maintained as given in circular No 262-362 dated 17/1/2005 and corrigendum dated 27/1/2005 issued by Directorate of Education.
10. That the school shall comply with the directions of Hon'ble Supreme Court of India regarding the arrangement made for transporting school students to and fro the school as per Circular No. DE 23(47)/School Br/2004/6942/ 66988 dated 29/9/2004 & 18/11/2005.
11. A certificate from the competent authority that the Building has been constructed as per National Building code 2005 within three months.
12. Salary & other facilities to staff and teachers will be made as per section 10(1) read with Rule 125 of DSEAR, 1973 and relevant section of RTE Act, 2009.



13. Salary to the staff should be made through crossed cheque/ Electronic clearance system.
14. That the school shall provide free and compulsory education to the children as per notification no. 15(172)/ DE/Act/2010/69 dated 7/1/2011.
15. That the annual return under rule 180 of DSEAR, 1973 shall be filled with the concerned Deputy Director of Education (District / Zone).
16. That the school abide by the instructions/orders regarding fee-hike, issued by the Dte. of Education.
17. In case of Provisional Recognition to the school situated in Non Confirming Area, the recognition will be subject to the outcome of notification by Ministry of Urban Development Govt. of India, Delhi.
18. That the violation of any instructions/orders/rules and regulations of the department, shall lead to the withdrawal of recognition of the school.
19. That the school shall submit certificate of rain water harvesting system issued from Delhi Jal Board within 30 days from the issuance of provisional recognition letter to the office of DDE (South East).
20. Payment of salary and other admissible allowances to its teaching/non-teaching staff as per on going CPC.
21. Appointment requisite teaching staff and HOS as per requirement and RRs laid down by DoE, GNCTD.
22. Complying with the provisions of RTE Act, 2009, DSEAR, 1973 and Directions/Instructions issued by the Department from time to time.
23. That the school shall comply with the provisions of Sections / Rules 176, 177, 18 (5), 17 (3) of DSEAR, 1973 & order dated 15.12.1999, 10.05.2005, 11.02.2009, 16.04.2010 & 19.02.2016 dealing with the regulation of fee along with the subsequent orders issued by DoE from time to time.
24. That the school shall comply with the orders dated 07.11.2017 / guidelines of DoE and judicial pronouncement with respect to safety and security of the students and take all necessary steps in this regard.
